4. Trailer Condition

The renter acknowledges the trailer has been inspected before pickup and accepts it in safe operating condition except for any damage noted below.

5. Renter Responsibilities

The renter agrees to:

- Inspect the trailer before towing.
- Use only a properly rated tow vehicle.
- Ensure all lights, brakes, safety chains, and breakaway cable are connected.
- Secure all loads.
- Obey all traffic laws.
- Return the trailer clean and free of debris.
- Return the trailer on or before the agreed return time.

6. Load Limits

The renter agrees NOT to:

- Exceed the trailer's weight capacity.
- Load material above the trailer sides.
- Place excessive tongue weight on the hitch.
- Transport oversized loads without proper permits.

Damage resulting from overloading is the renter's responsibility.

7. Prohibited Materials

The following materials are prohibited unless approved in writing:

- Hazardous waste
- Toxic chemicals
- Asbestos
- Paints or solvents
- Explosives
- Biohazard materials
- Radioactive materials
- Illegal substances
- Burning or smoldering materials

The following materials require prior approval and may incur additional fees:

- Concrete
- Asphalt
- Brick
- Dirt
- Gravel

8. Damage Responsibility

The renter is responsible for any damage occurring during the rental period, including but not limited to:

- Bent frame
- Damaged tongue
- Bent ramps
- Tailgate damage
- Hydraulic system damage
- Battery damage
- Electrical wiring damage
- Broken lights
- Tire damage caused by negligence
- Wheel damage
- Coupler damage
- Jack damage
- Winch damage (if equipped)
- Paint damage beyond normal wear

The renter agrees to pay the full cost of repairs or replacement.

9. Tire Damage

Flat tires caused by nails or normal road hazards may be repaired at the rental company's discretion.

Damage caused by:

- Overloading
- Curbing
- Burnouts
- Driving on flat tires
- Off-road misuse

shall be the responsibility of the renter.

10. Hydraulic System

The renter shall not:

- Tamper with hydraulic components.
- Disconnect hydraulic lines.
- Overload the dump system.
- Operate the dump bed on uneven ground.

Damage resulting from misuse shall be paid by the renter.

11. Loss or Theft

The renter assumes full responsibility for theft, vandalism, fire, or total loss of the trailer while it is in their possession.

12. Accidents

The renter agrees to immediately notify the rental company of any accident, damage, theft, or law enforcement contact involving the trailer.

The renter remains responsible for all damages regardless of fault to the extent permitted by applicable law, except where prohibited by law or covered under agreed insurance arrangements.

13. Insurance

The renter certifies they maintain valid automobile liability insurance that extends to towing this trailer and agrees to provide proof upon request.

The renter is responsible for any deductibles or uninsured losses resulting from damage during the rental period.

14. Indemnification

To the extent permitted by law, the renter agrees to indemnify and hold harmless the rental company from claims, damages, losses, and expenses arising from the renter's use, operation, or possession of the trailer, except to the extent caused by the rental company's negligence or willful misconduct.

15. No Warranty

The trailer is rented "as is," except that the rental company represents that it has been inspected and is believed to be in safe operating condition at the start of the rental.

16. Default

Failure to return the trailer, pay rental charges, or comply with this Agreement may result in:

- Additional rental charges
- Collection costs
- Attorney fees where permitted by law
- Civil legal action
- Reporting stolen equipment to law enforcement when appropriate

17. Governing Law
